

- Ajinomoto Group Creating Shared Value (ASV) Management: Returned to our Purpose (aspiration) and renewed our Vision. Incorported the concept of ASV into our systems, and instilled the corporate value enhancement cycle in our stakeholders.
- Employees: Improved engagement through the above. (Score greatly exceeds the scores of 69 other global food and beverage companies)
- Governance: Transitioned the company to a Company with Three Committees. Strengthened the supervisory functions of the Board of Directors and built a framework for speedy execution.
- Customers: During his term of office, improved overall brand value according to Interbrand by 7%, significantly exceeding the benchmark CAGR of 2%.
